

**Rule 5 of the Rajasthan Civil Services (Grant of Reward, Merit Awards and Merit Certificates) Rules, 1973**

**5. Rewards for writing Books, Articles, Pamphlets and Papers**

- (1) The Government may grant reward up to Rs. 10,000/- in respect of a Book, Pamphlet, Article of paper written on any subject which is adjudged to be of administrative or scientific or literary merit by the Board constituted under sub-rule (4) of this rule. The reward for the above work shall be in the three categories for Rs. 2500/-, Rs. 5000/- and Rs. 10,000/-.

*Provided that the Award shall not be given to a book, pamphlet, article or paper unless it was first published during the three years preceding the year of submission of application or in the year of submission of application for grant of award.*

- (2) The work for which reward is granted under this rule should be of original character, and not a mere compilation of information or facts for material collected from various sources.
- (3) The application for grant of reward under this rule shall be submitted by the Government Servant along with five copies of book, article etc. to the Chief Secretary to the Government through the Head of Department under, whom he is employed at the time of making the application.
- (4) The Chief Secretary will nominate a specialist on the subject to give his opinion in writing on the value and merit of the book, article etc. and on receipt of such opinion, it shall be assessed and adjudged by a Board consisting of the following:-

The Board shall submit its recommendation to the Government for grant of reward, if any, under these rules.

- (5) In case, a Government Servant who has applied for grant of cash Reward under this Rule, retires from the Government service on attaining the age of superannuation/dies before finalisation of his case, the amount of reward sanctioned to him, if any subsequently will be payable to him even after his retirement or in case of death, to his legal heirs.
- (6) The cash Award shall not be granted more than once for the same kind of works, provided that where in the opinion of the Board, the work done by a Government Servant, although related to the work done by him earlier, also qualifies as a new work or original nature independently, the same may also be considered.
- (7) No application for a second award shall be considered before the expiry of 5 years from the date of the sanction of the first award.


