ORDER

It has been decided that decisions taken in the last six months of the previous Government need to be reviewed.

In order to facilitate this, the following Committee is constituted to undertake a preliminary examination of such cases:

(a) Chief Secretary.

- (b) ACS/Principal Secretary/Secretary of the Administrative Department concerned Member Secretary.
- (c) Principal Secretary, Finance.
- (d) Secretary to Chief Minister.

The above mentioned Committee will review decisions of the previous Government in respect of the following categories of cases and submit its recommendations to a Cabinet Sub-Committee mentioned hereinafter:

- (a) Cabinet Decisions pending for implementation.
- (b) Cabinet Decisions which have already been implemented.
- (c) Decisions taken at the level of Chief Minister/Minister/ACS/Pr. Secretaries/Secretaries where a possibility exists of extending benefit to private persons/ organizations. In this category, cases of housing/allotment of land will be taken up.
- (d) Award of contracts by State Government/HOD in violation of established norms.
- (e) Review of schemes/projects/programmes falling in categories other than those at serial numbers (a) to (d) above which were implemented during the period of last six months of the previous Government and considered appropriate for review by the Committee headed by the Chief Secretary.

The Cabinet Sub-Committee mentioned above shall submit its recommendations to the Chief Minister for final decision and is constituted as under:

- 1. Shri Gulab Chand Kataria
- 2. Shri Rajendra Rathore Convenor
- 3. Shri Kali Charan Saraf.
- 4. Shri Arun Chaturvedi

The Committee under the Chief Secretary shall submit its recommendations to the Cabinet Sub-Committee within a period of 15 days from the date of issue of this order.

The Cabinet Sub-Committee, in turn, shall submit its recommendations to the Chief Minister within a period of 15 days thereafter.

The Cabinet Secretariat will be the Administrative Department for this Cabinet Sub-Committee and its Secretary would be the Additional Chief Secretary/Principal Secretary/Secretary, Cabinet Secretariat.
