In supersession of all existing orders regarding delegation of powers under Rajasthan Service Rules and Classification, Control and Appeal Rules, 1958 the following delegations are made, which will be in force with immediate effect:-

1. The Superintendent/Managers of the various Circuit Houses and the Supervisor, Government Hostel, Jaipur are hereby declared head of office for purposes of R.S.R. and C.C.A. Rules.
2. The Collectors, in their respective jurisdictions shall be the counter-signing authorities for the Supts./Managers and are also authorised to sanction casual leave to them.  
The casual leave of the Manager, Rajasthan House New Bhill and Circuit House, Jaipur and Supervisor, Government Hostel, Jaipur will be sanctioned and their personal claims countersigned by the undersigned.
3. The Collector, Bundi will be the Head of office in addition to his being the countersigning authority in respect of the Circuit House, Bundi as no post of Manager, exists there.

The powers already enjoyed under the delegation made under General Financial and Accounts Rules will continue as heretofore.


