**1. Short title and commencement.-** (1) These rules may be called the Rajasthan Ministers' Official Residences (Use and Maintenance) (Amendment) Rules, 2012.

(2) They shall be deemed to have come into force on and from 1st April, 2012.

**2. Amendment of rule 4.-** In sub-rule (1) of rule 4 of the Rajasthan Ministers Official Residences (Use and Maintenance) Rules, 1966,-


- (i) in clause (a), for the existing expression "Rs.1,50,000/-", the expression "Rs:2,50,000/-" shall be substituted .
- (ii) in clause (b) for the existing expression "Rs. 1,25,000/-", wherever occurring, the expression Rs. 2,00,000/-" shall be substituted.

**1. Short title and commencement .-** (1) These rules may be called the Rajasthan Ministers' (Concession on Account of Electricity and Water) (Amendment) Rules, 2012.


(2) They shall be deemed to have come into force on and from 1st April, 2012.

**2. Amendment of rule 2 .-** The existing rule 2 of the Rajasthan Ministers' (Concession on Account of Electricity and Water) Rules, 1965, shall be substituted by the following; namely:-

**"2. Concession on Account of Electricity and Water .-** For the purpose of section 5-A of the Rajasthan Ministers' Salaries Act, 1956 (Act No. 43 of 1956), each Minister shall be entitled to the concession of payment by the Government for him and on his behalf, throughout his term of office, of all charge due from him on account of consumption of electricity and water at his residence, provided that such payment shall not exceed the limits specified below:-

S.No.	Residence of	Electricity and Water
1	2	3
1.	Chief Minister	60,000 units of electricity and 90 lakhs liters of water per annum
2.	Ministers/State Ministers	35,000 units of electricity and 50 lakhs liters of water per annum



In exercise of the powers conferred by sub-section (2) section 5 read with section 6 of the Rajasthan Minister's Salaries Act, 1956 (Act No. 43 of 1956), the Governor is pleased to make the following rules further to amend the Rajasthan Ministers (Travelling Allowances and Use and Maintenance of Conveyance) Rules, 1974, namely :-

1- **Short title and commencement.**- (1) These rules may be called the Rajasthan Ministers (Travelling Allowances and Use and Maintenance of Conveyance) Rules, 2012.


(2) They shall be deemed to have come into force on and from 1<sup>st</sup> April, 2012.

2- **Amendment of rule 4.**- In sub rule (2) of rule 4 of the Rajasthan Ministers ((Travelling Allowances and Use and Maintenance of Conveyance) Rules, 1974, hereinafter referred to as the said rules,-

- (i) in clause (a) for the existing expression "4 Paise", the expression "7 Paise" shall be substituted
- (ii) in clause (b) for the existing expression "Rs. 3.75 ", the expression "Rs. 7.00" shall be substituted.
- (iii) in clause (d) for the existing expression "Rs. 700/- per day within State and Rs. 800/- per day outside the State", the expression "Rs. 1000/- per day within the State and Rs. 1250/- per day outside the State" shall be substituted.

3. **Amendment of rule 5.** - In sub-rule (3) of rule 5 of the said rules for the existing expression "2400 and 5475 liters", the expression "4000 and 7500 liters shall be substituted.




