- 4. Science & Engineering (Includes Space Engineering, Nuclear Science, Information Technology, Reserch & Development in Science & its allied subjects etc.)
- 5. Trade and Industry (Includes Banking, Economic Activities, Management, Promotion of Tourism Business etc.)
- 6. Medicine (Includes medical research, distinction/specialization in Ayurveda, Homeopathy, Sidhha, Allopathy, Naturopathy etc.)
- 7. Literature & Education (Includes Journalism, Teaching, Book composing, Literature, Poetry, Promotion of education, promotion of literacy, Education Reforms etc.)

- 8. Civil Service (Includes distinction/excellence in administration etc. by Government Servants)
- 9. Sports (Including popular Sports, Athletics, Adventure, Mountaineering, promotion of sports, Yoga etc.)
- 10. Others (Fields not covered above and may include propagation of Indian Culture, Protection of Human Rights, Wild Life Protection/Conservation etc.)

Instituted in 1954, these Awards are announced on the occasion of the Republic Day every year. The award seeks to recognize work of distinction and is given for distinguished and exceptional achievements/service in all fields/disciplines, such as, Art, Literature and Education, Sports, Medicine, Social Work, Science and Engineering, Public Affairs, Civil Service. Trade and Industry etc. All persons without distinction of race, occupation, position or sex are eligible for these Awards. A copy of the statutes and rules governing these Awards is available on the website https://padmaawards.gov.in.

- 2. It is the convention to in the nominations for these Awards from all States/ UI Governments as also from severable their sources to enable broad-based consideration.
- 3. The nominations/recommer lations for the Padma Awards will be received only on the online portal https://pac.naawards.gov.in designed for this purpose. The nominations / recommendations should contain all relevant details specified in the format available on the above portal, including a citation in narrative form (maximum 800 words), clearly bringing out the distinguished and exceptional achievements/service of person recommended in his/acc respective field/discipline. While recommending a person online, it should be ensured that all the necessary details are properly filled. The steps to be taken for making online recommendations are available on above said website https://padmaawards.gov.in.
- 4. It has been observed in the post that while nominations are received in respect of a large number of persons; there could, however, be several talented persons who are left out of consideration despite exceptional contribution in their field. Often many such persons may get overlooked primary for the reason that they may not seek publicity or attention in the public domain. It is, therefore, requested to make concerted efforts in identifying such persons whose end llence and achievements deserve to be recognized and make suitable nominations in their favour. It goes without saying that recognition of such deserving persons will only add to the prestige of these Awards.
 - 5. In the above background, I recliest you to kindly send suitable nominations for the Padma Awards to be announced on " e occasion of Republic Day, 2022. In this regard, it is suggested that you may constitute a Special Search Committee for identifying.

considering and finalizing your recommendations/nominations. While finalizing recommendations, the following points may be kept in view:-

- (i) Persons recommended are pre-eminently worthy of the Awards, looking at their life-time achievements. The criteria for selection should invariably be 'excellence plus' and the highest standards should be applied while recommending persons for these awards. The existence of an element of public service in the achievements of the person recommended for the award would be a desirable factor.
- (ii) As the Padma Award is the second highest civilian award of the country, it should also be considered whether the recommended person has earlier been given any National award or a State award in his/her respective field.
- (iii) Efforts may be made to identify talented persons from amongst women weaker sections of the society, SCs & STs, divyang persons, etc., who deserve to be considered for the award.
- (iv) The decoration is normally not conferred posthumously. However, in highly deserving cases. Government could consider giving an award posthumously if the demise of the person proposed to be honoured has been recent, say within a period of one year preceding the Republic Day on which it is proposed to announce the award.
- (v) A higher category of Padma Award can be considered in respect of a person who has earlier been conferred an award, provided a period of at least five years has elapsed. However, in exceptionally deserving cases, a relaxation can also be considered.
- (vi) Government servants including those working with PSUs, except Doctors and
 Scientists, are not eligible for Padma Awards.
- 6. The online nominations / recommendations for the Padma Awards will begin from June 1st, 2021 and the last date for nominations is September 15th, 2021. The cut-off date may please be strictly adhered to as nominations / recommendations received only during 1st June. 2021 to 15th September, 2021 will be considered. It may also be noted that the nominations/recommendations received through online mode only will be considered.

पदा पुरस्कार, अर्थात, पदा विभूषण, पदा भूषण और पदा श्री, देश के सर्वोच्च नागरिक पुरस्कार हैं। 1954 में स्थापित, इन पुरस्कारों की घोषणा प्रत्येक वर्ष गणतंत्र दिवस के अवसर पर की जाती है। इस पुरस्कार में "उत्कृष्ट कार्य" को मान्यता प्रदान की जाती है और इसे सभी क्षेत्रों/विषयों जैसे कला, साहित्य और शिक्षा, खेल, चिकित्सा, सामाजिक कार्य, विज्ञान और इंजीनियरी, सार्वजनिक मामलों, नागरिक सेवा, व्यापार और उद्योग आदि में विशिष्ट और असाधारण उपलब्धियों/सेवा के लिए प्रदान किया जाता है। कोई भी व्यक्ति, किसी जाति, व्यवसाय, हैसियत या लिंग के भेदभाव के बिना, इन पुरस्कारों के पात्र है। इन पुरस्कारों से संबंधित विधान और नियमावली वेबसाइट https://padmaawards.gov.in पर उपलब्ध है।

- 2. इन पुरस्कारों के लिए सभी राज्यों/संघ राज्य क्षेत्र सरकारों के साथ-साथ अनेक अन्य स्रोतों से भी नामांकन आमंत्रित करने की परंपरा है ताकि इन पर व्यापक विचार-विमर्श किया जा सके।
- 3. पद्म पुरस्कार के लिए नामांकन/सिफारिशें केवल ऑनलाइन पोर्टल https://padmaawards.gov.in पर स्वीकार की जाएंगी जिसे इसी उद्देश्य के लिए डिज़ाइन किया गया है। नामांकन/सिफारिश में अनुशंसित व्यक्ति की उससे संबन्धित क्षेत्र/विषय में विशिष्ट और असाधारण उपलब्धियों का स्पष्ट रूप से उल्लेख करते हुए विवरणात्मक रूप में प्रशस्ति पत्र (अधिकतम 800 शब्द) सिहत उपर्युक्त पोर्टल पर उपलब्ध प्रारूप में उल्लिखित सभी प्रासंगिक जानकारी दी जानी चाहिए। किसी व्यक्ति की ऑनलाइन सिफारिश करते समय, यह सुनिश्चित किया जाना चाहिए कि सभी आवश्यक विवरण ठीक से भरे गए हैं। ऑनलाइन सिफारिश करने की क्रमवार प्रक्रिया उपर्युक्त वेबसाइट https://padmaawards.gov.in पर बताई गई है।
- 4. अतीत में देखा गया है कि बड़ी संख्या में व्यक्तियों के संबंध में नामांकन प्राप्त होते हैं, लेकिन असाधारण योगदान के बावजूद कई प्रतिभाशाली व्यक्तियों के नाम पर विचार नहीं किया जाता है। ज्यादातर ऐसे लोगों की मुख्य रूप से इस कारण से अनदेखें रहने की संभावना रहती है कि उन्हें अपने सार्वजिनक जीवन में प्रचार या प्रमुखता की आकांक्षा नहीं रहती है। इसलिए, अनुरोध है कि ऐसे व्यक्तियों की पहचान करने के पूरे प्रयास किए जाएं जिनका उत्कृष्ट प्रदर्शन और उपलब्धियां सम्मान योग्य हैं, और उनका उपयुक्त नामांकन किया जाए। यह उल्लेख करना आवश्यक है कि ऐसे योग्य व्यक्तियों के सम्मान से इन पुरस्कारों की प्रतिष्ठा में वृद्धि होगी।
- 5. उपर्युक्त पृष्ठभूमि में, में अनुरोध करता हूं कि कृपया गणतंत्र दिवस. 2022 के अवसर पर घोषित किए जाने वाले पद्म पुरस्कार के लिए उपयुक्त नामांकन प्रेषित करें। इस संबंध में, यह सुझाव दिया जाता है कि आप पहचान, विचार और अपनी संस्तुति/नामांकन को अंतिम रूप देने के लिए एक विशेष जांच समिति का गठन कर सकते हैं। सिफारिशों को अंतिम रूप देते समय, निम्नलिखित बातों को ध्यान में रखा जाना चाहिए: -
 - (i) जिन व्यक्तियों की सिफारिश की गई है, उनकी जीवनभर की उपलब्धि को देखते हुए, वे इस पुरस्कार के सर्वथा योग्य हों। चयन के लिए मानदंड अनिवार्य रूप से 'अत्यंत उत्कृष्ट' होना चाहिए और इन पुरस्कारों के लिए व्यक्तियों की सिफारिश करते समय उच्चतम मानदंडों के आधार को अपनाना चाहिए। पुरस्कार के लिए अनुशंसित व्यक्ति की उपलब्धियों में सार्वजनिक सेवा एक वांछनीय घटक होगा।

- (ii) चूंकि पद्म पुरस्कार देश का दूसरा सर्वोच्च नागरिक पुरस्कार है, इसलिए यह भी विचारकिया जानाचाहिए कि क्या अनुशंसित व्यक्ति को इससे पहले उनके संबंधित क्षेत्र में किसी राष्ट्रीय पुरस्कार या राज्य पुरस्कार से सम्मानित किया गया है अथवा नहीं।
- (iii) इन पुरस्कारों के लिए महिलाओं, समाज के कमजोर वर्गों, जैसे अनुसूचित जातियों और जनजातियों, दिव्यांग व्यक्तियों, आदि में से ऐसे प्रतिभाशाली व्यक्तियों की पहचान करने के प्रयास किए जाएं जो पुरस्कार के लिए विचार किए जाने के हकदार हैं।
- (iv) यह पुरस्कार आमतौर पर मरणोपरांत नहीं दिया जाता है। तथापि, अत्यंत पात्र गागलों में, सरकार मरणोपरांत पुरस्कार देने पर विचार कर सकती है, यदि सम्मानित किए जाने वाले व्यक्ति का निधन हाल ही के उस गणतंत्र दिवस से पहले एक वर्ष की अवधि के भीतर हुआ हो, जिस पर पुरस्कार की घोषणा किए जाने का प्रस्ताव है।
- (v) उच्चतर श्रेणी के पद्म पुरस्कार के लिए उस व्यक्ति के बारे में भी विचार किया जा सकता है जिन्हें यह पुरस्कार पहले प्रदान किया गया हो, बशर्ते इस बीच कम से कम पांच साल की अविध बीत गई हो। हालांकि, असाधारण रूप से पात्र मामलों मेंछूट देने पर भी विचार किया जा सकता है।
- (vi) डॉक्टरों और वैज्ञानिकों को छोड़कर, सार्वजनिक क्षेत्र उपक्रमों में काम करने वाले व्यक्तियों सहित सरकारी सेवक, पद्म पुरस्कार के लिए पात्र नहीं हैं।

6. पद्म पुरस्कार के लिए ऑनलाइन नामांकन/सिफारिश का कार्य 1 जून, 2021 से शुरू होगा और नामांकन की अंतिम तिथि 15 सितम्बर, 2021 है। अंतिम तिथि का सख्ती से पालन किया जाए क्योंकि 1 जून, 2021 से 15 सितम्बर, 2021 के बीच प्राप्त नामांकनों पर ही विचार किया जाएगा। यह भी ध्यान रखा जाना चाहिए कि केवल ऑनलाइन प्राप्त नामांकन/सिफारिशों पर ही विचार किया जाएगा।

- 2. The decoration shall, be mainly circular in design, with a geometrical pattern superimposed on the circle (as in the representative drawing in the annexure). The diameter of the circular portion of the decoration shall be one and three-fourth inches and the thickness of the decoration shall be one-eighth of an inch. The geometrical pattern shall be composed of the outer lines of a square of one and three-sixteenths inches side, centrally placed on each side of which shall be a rectangle projecting beyond the rim thereby breaking the circumference of the circular design of the decoration. A knob shall be embossed within each of the outer angles of the geometrical pattern. There shall be a raised circular space of diameter one and one-sixteenth inches forming the centre-piece of the decoration. On the obverse a lotus flower shall be embossed in this circular space. The name of the decoration shall be embossed in Hindi, with the word PADMA placed above and the word VIEHUSHAN placed below the lotus flower. On the reverse shall be embossed the State Emblem and motto in Hinds below it. The decoration shall be of toned bronze. @The inscription PADMA VIBHUSHAN on the obverse of the decorution, the geometrical pattern on either side and the border around the periphery, shall be of burnished bronze. All embossing on either side of the decoration shall be of white gold.
- 3. A sealed pattern of the decoration (manufactured according to the specifications described above and the drawing in the annexure to these regulations) shall be deposited and kept.





All embossing on either side of the decoration shall be of standard gold.
- 3. A scaled pattern of the decoration (manufactured according to the specifications described above and the drawing in the annexure to these regulations) shall be deposited and kept.


