## SECTION II TERMS & CONDITIONS

#### 1. GENERAL

#### 1.1 Scope of Bid

- 1.1.1 The Government of Rajasthan (GOR), India, (hereinafter referred to as "the Seller") wishes to sell a Beechcraft manufactured KING AIR C-90A Aircraft Regn No: VT-EQN, Serial No-LJ-1167 along with available spares, Special tools and Technical Literature in "As is where is and whatever there is basis". The details of the Aircraft are given in Section III.
- 1.1.2 Interested bidders will have to offer their price online in the auction process for purchasing the Aircraft along with spares in Indian Rupees only.
- 1.1.3 It will be the responsibility of the successful bidder to obtain all permissions from concerned authorities for transfer of ownership and, in case, successful bidder is located outside India, permission for export of the Aircraft. All the costs for transfer of ownership of Aircraft along with spares, any taxes or duties that may be payable and cost of transporting including insurance and other such costs, outstanding, dues etc. will have to be borne by the successful bidder.

#### 1.2 Inspection of Aircraft and Spares & Special Tools

1.2.1 The bidder, prior to take part in the auction process of the Aircraft, may visit and inspect the Aircraft along with spares and tools, at his/her own expense and obtain and ascertain for himself on his own responsibility, all information, data, etc. including actual conditions regarding state and condition of the Aircraft, log books, etc., that may be desirable for his/her offer.

One working days notice will be required for preparation of entry pass, if required. Interested bidders will be required to submit two copies of current passport size photographs along with Aadhar card, Photo-copy of Proof of identity and residence. The contact person is Director, Directorate of Civil Aviation, Government of Rajasthan.

1.2.2 The Interested bidders should go through the Term & Conditions of the Auction. The bidder shall be deemed to have full knowledge concerning the Aircraft along with spares and tools.

#### 2. AUCTION DOCUMENTS

#### 2.1 Auction Documents

- 2.1.1 The specifications of the Aircraft to be sold, Auction procedure and Purchase Agreement terms are prescribed in the Auction Documents.
- 2.1.2 The bidder is expected to examine the Auction Documents, including all instructions, schedules, annexure, terms and specifications. Failure to furnish all information as per the Auction Documents shall result in ineligibility for taking part in the auction

#### 2.2 Clarification of Auction Documents

2.2.1 Prospective Bidders requiring any further information or clarification on the Auction Documents may notify the Seller in writing or through email at the seller's malling address indicated in the invitation for pids. The seller will address to any request for information or clarification of the Auction Documents which it receives not later than seven (7) days prior to schedule date of open e-Auction.

#### 2.3 Amendment of Auction Documents

- 2.3.1 At any time, prior to the deadline for Auction process, the Seller may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the Auction Documents by amendment.
- 2.3.2 The amendment shall be part of the Auction Documents, pursuant to Clause 2.1.1, and it will be notified in writing or by fax/E-mail to all prospective bidders and will be binding on them. The seller may also indicate such amendments on the website <a href="www.gad.Rajasthan.gov.in">www.gad.Rajasthan.gov.in</a> and

2.3.3 In order to allow the prospective bidders a reasonable time, in which to take the amendment/s into account in preparing their bids, the Seller may, extend the deadline for submission of Bids.

#### 3. PREPARATION OF BIDS

#### 3.1 Language of Bids

3.1.1 The Bid prepared by the bidder and all correspondence and documents Relating to the Bid exchanged by the bidder and the Seller, shall be written in "English" language only.

#### 3.2 Bid Prices

- 3.2.1 The bidder shall offer a price for the Aircraft along with its spares and special tools on an "As is where is and whatever there is basis" in the e-open auction process.
- 3.2.2 The cost of transportation, insurance, obtaining requisite clearances from appropriate authorities, etc., will have to be borne by the bidder.
- 3.2.3 The Prices offered by the bidder shall remain fixed and valid until completion of the contract and will not be subject to variation on any account.

## 3.3 Reserve Price of State Aircraft KING AIR C90A VT-EQN, S/N-LJ-1167 and Bid Currency:

- 3.3.1 Prices shall be offered in Indian Rupees only.
- 3.3.2 Reserve Price shall be Rs.3.50 crores and starting price of the auction shall be Rs.3.25 crores.
- 3.3.3 The Successful bidder shall be liable to pay all additional applicable state/central govt. Taxes like GST etc.over and above from the his/her offered bid amounts.

#### 3.4 Bid Security and Payments

- 3.4.1 The bidder shall furnish prior to Auction, participation fee amounting to Rs.1.00 lac (Non –refundable) and Pre Bid EMD amount of Rs. 7.00 lacs only (In Word seven lacs only) refundable.
- 3.4.2 In the case of successful bidder, the bidder shall furnish an EMD amount of equal to 25% of the successful Bid Value within 07 (Seven) days from the close of e-Auction failing which Pre Bid EMD may be forfeited by the department and material offered for re-Auction without any further claim to the Bidder. On submission of 25% EMD within 7 days of close of eAuction, Sale Order/Acceptance Letter shall be issued by MSTC to Bidder. Balance 75% amount along with all applicable taxes and duties shall be deposited by Bidder within 21 days from the date issue of Sale Order by MSTC. In case the bidder deposits 25% EMD in 7 days but fails to submit balance 75% in next 21 days, then penalty of 1% of bid value per week shall have to be paid additionally by bidder from expiry of payment period of 21 days till submission of payment, subject to maximum of 2 weeks from the expiry of payment period of 21 days. In case of non submission of payment within maximum allowable period, 25% EMD amount submitted by the bidder will be forfeited and bid shall stand cancelled. The Department shall be free to re-auction the material without any further claim to the bidder. The bidder has to submit written request for extension of Payment period with penalty beyond 21 days to the Department before expiry of stipulated Payment period for prior approval of the Government.

Bid EMD payment at least one day before the e-Auction.

3.4.3.1 In the case of an unsuccessful bidder, the bid security would be returned after the close of e-Auction on demand by the bidder within 3 working days.

3.4.3.2 In the case of the successful bidder, the bid security will be discharged / returned upon the bidder successfully executing the contract and paying the 25% of bid amount to the seller within 7 days of closing of eAuction.

#### 3.5 Forfeiture of Bid Security

3.5.1 The Pre Bid EMD of the bidder may be forfeited if the bidder fails to submit 25% EMD to the Department within 7 days from the close of eAuction.

3.5.2 In case of successful bid, 25% EMD shall be forfeited if the bidder fails to submit 75% Balance Payment to the Department within 21 days from the issue of Sale Order/Acceptance Letter by MSTC to the Bidder.

3.5.3 In case 100% amount has been deposited by the bidder, full amount may be forfeited by the Department if the bidder fails to (i) execute the Agreement (as per Section IV), and / or (ii) honor stipulated terms and conditions, make payments and take delivery of the material as per terms of contract (iii) fails to get the document transferred within 60 days from the date of award of contract by Department, (iv) Remove the Aircraft from state hangar within 120 days (60 days free period and 60 days penalty period as per caluse 4.4 below) from the award of contract by Department.

#### 3.6 Period & Validity of Bids

3.6.1 Bids shall remain valid for **03** (three) months after the date of the Auction or acceptance by the Seller as per the relevant clause of the documents.

3.6.2 Notwithstanding clause 3.6.1 above, the Seller may solicit the bidder's consent to an extension of the period of bid validity. The request and the responses thereto shall be made in writing or through email. If the bidder agrees to the bid request, the validity of the bid security

provided under clause 3.5 shall also have to be suitably extended.

## 3.7 Date and time for taking part in the e-open Auction Process

3.7.1 The Seller may, at its discretion, extend the deadline for the e-open Auction Process in accordance with Clause 2.3, in which case all rights and obligations of the Seller and bidders previously subject to the deadline will thereafter be subject to the deadline as extended.

3.7.2 The bidder himself through their MSTC log in may take part in the auction process.

## 4. OPEN AUCTION FOR SALE OF AIRCRAFT AND EVALUATION

4.1 Open Auction by Seller

The Seller will sell the Aircraft to the highest bidder (the price offered by the bidder shall be subject to the satisfactory and acceptance by the Government of Rajasthan) through online auction process on <a href="www.mstcecommerce.com">www.mstcecommerce.com</a>. The Government of Rajasthan has reserves the right to accept, reject any or all the bids and also this entire auction process.

#### 4.2 Process to be confidential

Information relating to the examination, clarification, evaluation and comparison of bids and recommendations for the award of a contract shall not be disclosed to bidders or any other persons not officially concerned with such process. Any effort by a bidder to influence the Seller's processing of Bids or award decisions may result in the rejection of the bidder's bid.

#### 4.3 Clarification of Bids

To assist in the examination, evaluation and comparison of bids, the Seller may, at its discretion, ask the bidder for a clarification of its bid. All responses to requests for clarification shall be in writing.

#### 4.4 Delivery Schedule

The Aircraft covered by this auction is required to be taken in possession by the successful bidder immediately after the issuance of Delivery Order and successful document transfer in his name and remove the aircraft from State Hanger location within 60 days from the Award of Contract by the Department. In case the aircraft is

not removed from present location in the given time, State Government will charge the buyer Rs.10, 000/- per day per aircraft for parking in the State Hangar subject to maximum of 60 days from the expiry of free lifting period mentioned above. The bidder has to submit written request for extension of Lifting period with penalty to the Department before expiry of free lifting period for prior approval of the Government.

## 4.5 Seller's Right to Accept Any Bid and to reject any or All Bids

The Seller reserves the right to accept or reject any bid and to annul the Auction process and reject all bids at any time prior to award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for the Seller's action.

#### 5. AWARD OF CONTRACT

#### 5.1 Post qualification and Award

- 5.1.1 In case where the result of e-Auction is STA (i.e., Highest bid received is lower than the reserve price but is within the predefined STA range), seller shall provide their decision of acceptance or rejection of bid.
- 5.1.2 If the highest bid is accepted by the seller, then buyer has to make payments as per schedule given in this document.
- 5.1.3 If the highest bid is rejected by the seller, then bid security of highest bidder shall be returned and sale shall be considered as cancelled.

#### 5.2 Notification of Award

- 5.2.1 The Seller will notify the successful bidder in writing or through e-mail.
- 5.2.2 The notification of award will constitute the formation of a contract.

### 5.3 Signing of Contract

After the receipt of notification of award and depositing 25% of the bid amount, the successful bidder shall indicate his acceptance to the same and sign & date the Contract and return it to the Seller.

## 5.4 Extensions in the Purchaser's Performance

5.4.1 The Purchaser may claim extension of the time limits as set forth in the Contract Execution Schedule in case of:

5.4.2 Force Majeure pursuant to Clause 5.10; and

5.4.3 Delay in performance of work caused by orders issued by the Seller. The Purchaser shall demonstrate to the Seller's satisfaction that it has used its best endeavors to avoid or overcome such causes for delay, and the parties will mutually agree upon remedies to mitigate or overcome such causes for delay.

5.4.4 Notwithstanding Clause above, the Purchaser shall not be entitled to right to an extension of time for completion unless the Purchaser, at the time of auch circumstances arising, immediately has notified the Seller in writing of any delay that it may claim as caused by circumstances pursuant to Clause above; and upon request of the Seller, the Purchaser shall substantiate that the delay is due to the circumstances referred to by the Purchaser.

#### 5.5 Termination of contract for Default

- 5.5.1 The Seller may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Purchaser, terminate the Contract in whole or in part:
- 5.5.2 if the purchaser fails to take delivery of the Aircraft / spares /Special Tools within the time period specified in the Contract, or any extension thereof granted by the Seller, pursuant to Clause 5.4; or
- 5.5.3 If the purchaser fails to perform any other obligation(s) under the contract; and
- 5.5.4 If the purchaser, in either of the above circumstances, does not cure its failure within a period of 10 calendar days (or such longer period as the Seller may authorize in writing) after receipt of a notice of default from the Seller specifying the nature of the default(s).
- 5.5.5 If the purchaser fails to deposit remaining 75% amount, as offered through the open Auction process with in the stipulated time.

#### 5.6 Termination for Insolvency

The Seller may at any time terminate the Contract by giving written notice to the Purchaser, without compensation to the Purchaser, if the Purchaser becomes bankrupt or otherwise insolvent. Notwithstanding the above, such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the Seller.

#### 5.7 Termination for Convenience

The Seller may, by written notice sent to the Purchaser, terminate the Contract, in whole or in part, at any time for its convenience. The notice of termination shall specify that termination is for the Seller's convenience, the extent to which performance of work under the Contract is terminated, and the date upon which such termination becomes effective.

#### 5.8 Resolution of Disputes

The Seller and the Purchaser shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the Contract.

#### 5.9 Applicable Law & Jurisdiction

The Contract shall be governed by and interpreted in accordance with the Laws of India. The jurisdiction for any legal action or proceedings will be Courts of Jaipur, Rajasthan, INDIA.

#### 5.10 Force Majeure

5.10.1 In the event that the Purchaser or the Seller is delayed in performing any of their respective obligations under the Contract, and such delay is caused by Force Majeure, including but not limited to war, civil insurrection, fires, floods, epidemics, earthquakes, quarantine restrictions and freight embargoes, such delay may be excused as provided in Clause 5.4, and the period of such delay may be added to the time of performance of the obligation delayed.

5.10.2 If a Force Majeure situation arises, the Purchaser shall promptly notify the Seller in writing of such condition and the cause thereof. Unless otherwise directed by the Seller in writing, the Purchaser shall continue to perform its obligations under the Contract as far as it's reasonably practical and shall seek all reasonable alternative means for performance, not


