In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan is hereby pleased to make the following rules further to amend the Rajasthan Civil Services (Allotment of Residential Accommodation) Rules, 1958 namely:-

1- Short title and commencement:- (1) These rules may be called the Rajasthan Civil Services (Allotment of Residential Accommodation) (Amendment), Rules, 2023.

(2) They shall come into force with immediate effect.

2- Amendment in rule 12 :- In rule 12 of the Rajasthan Civil Services (Allotment of Residential Accommodation) Rules, 1958 after the existing sub-rule (b), the following new sub-rule (c) shall be added, namely:-

"(c) Notwithstanding anything contained in sub-rule (b) above, a Female Government servant to whom government accommodation has been allotted under these rules may retain such house on normal rent till the end of her maternity leave, if she continues to reside in that house. However provisions of this sub-rule shall not apply for earmarked house."
